Phase 1 construction will consist of clearing/grubbing a 4.5-acre area, placing clean fill material and compacting to meet current IBC certification for future buildout on the site. Phase 2 construction will consist of the construction of approximately 0.25 miles of new roadway. The work involves approximately 2.8-acres of roadway. This will include the placement of crushed surfacing top and base course, HMA 1/2", cement concrete traffic curb and gutter, asphalt pathway, installation of curb cuts, storm ditch, waterline, sewer line, illumination system, mulch, signage and striping.

**Yes, Phase 1 construction includes filling in an existing low depression on the site to make the property level, so in the future the property can be sold. Phase 2 will be the construction of the proposed Logan Street Extension. There will be minimal earthwork as the proposed road alignment will match the existing ground contours.**

The stormwater will be collected in the road side ditch along the proposed new road and treated by the natural dryland grass that will be hydroseeded at the completion on the project. The natural dryland grass will provide the treatment required prior to infiltrating through the surface of the roadside ditches.

2) Could waste materials enter ground or surface waters? If so, generally describe: **No, the stormwater is being treated in a manner that is miles from the closest surface waters, and there is no record of groundwater in this location.**


