## INTERLOCAL COOPERATIVE AGREEMENT between the city of pichland and the popt of kennewick. Wa

## THE CITY OF RICHLAND AND THE PORT OF KENNEWICK, WASHINGTON, for FOWLER AND GEORGIA STREET IMPROVEMENT PARTNERSHIP

day of December, 2010 between the City of Richland, Washington, a Washington Municipal Corporation and the Port of Kennewick, Washington, referred to as the "Jurisdictions".

**WHEREAS**, the Jurisdictions are, pursuant to Chapter 39.34 RCW (the Interlocal Cooperation Act), authorized to exercise their powers jointly, thereby maximizing their ability to provide services and facilities which will best fulfill common needs of the Jurisdictions, and;

**WHEREAS**, the Jurisdictions have determined that Fowler and Georgia Streets and associated underground utilities adjacent thereto or nearby, are in need of improvements in Richland, Washington to serve the Spaulding Business Park economic development, which is in the best interest of the Jurisdictions and the public and;

WHEREAS, said project will help the economic development of the area; and

**WHEREAS**, the Jurisdictions, by their respective governing bodies, have determined this effort may be best implemented on a shared basis in a manner deemed most efficient and effective for the Jurisdictions;

**NOW, THEREFORE,** in consideration of the mutual covenants contained herein, the Jurisdictions agree as follows:

- **Section 1. Purpose.** The purpose of this Agreement is to formalize a commitment to improve the Business Park by installing upgraded underground utilities the Business Park located in Richland, Washington (the Project).
- Section 2. Administration. This Agreement shall be administered by the Richland City Manager or his designee. Such person shall be responsible for:
  - (a) Establishing policies for implementing this Agreement;
- (b) Providing periodic progress reports to the elected officials of each Jurisdiction;
- (c) Monitoring progress of the Jurisdictions and other agencies in the fulfillment of their respective responsibilities.

**Section 3. Funding.** Each Jurisdiction hereby commits to provide funding as set forth below:

(a) City of Richland, Washington: \$13,560.30

(b) Port of Kennewick \$7,350.00

Such funding shall be used for actual construction work for the Project.

Section 4. Modification. This Agreement may be modified only by unanimous written consent of each Jurisdiction.

## Section 5. Term Of Agreement And Termination.

- (a) The term of this Agreement shall become effective on full execution hereof.
- (b) This Agreement shall expire on the date of completion of the Project.

Section 6. Inspection Of Records. The records and documents with respect to all matters covered by this Agreement shall be subject to inspection by any Jurisdiction during the term of this Agreement and for three years after its termination.

Section 7. No Separate Legal Entity. It is not the intention that a separate legal entity be established to conduct the cooperative undertaking nor is the acquiring, holding or disposing of real or personal property anticipated.

Section 8. Severability. In the event any term or condition of this Agreement or application thereof to any person, entity or circumstance is held invalid, such invalidity shall not effect any other terms, conditions or applications of this Agreement which can be given effect without the invalid term, condition, or application. To this end, the terms and conditions of this Agreement are declared severable.
